In Honor of Dr. Erma Lawrence

Áljuhl- Beautiful One 1912-2011

Our dearly beloved Erma Lawrence passed away peacefully with her family by her side on February 21, 2011 in Seattle. Erma was born in Kasaan on August 2, 1912, and her Haida name was Áljuhl (Beautiful). She belonged to the Ts'eihl 'Láanaas Eagle clan. Her mother was Nellie Helen Scott Baronovich and her father was Nicholas Charles Baronovich.

Ájuhl's maternal grandparents were Edwin and Emma Alexander Scott. Her paternal grandparents were Charles Vincent and Mary-Ann Skáwaal-Baronovich, daughter of Chief Skáwaal of Kasaan. In addition to living in Kasaan and Hydaburg, Erma also lived in Haines, Ketchikan and Wrangell. She was a lifetime member and Camp Mother of the Alaska Native Sisterhood (ANS) Camp #14, and a devoted member of the Presbyterian Church.

Erma was an accomplished and generous woman. In the 1970s, she worked with other Haida elders to create a Haida language writing system which resulted in the publication of the first Alaskan Haida dictionary, and she was the first Haida language teacher at Ketchikan Community College. In 2004, she received an

Honorary Doctorate from the University of Alaska Southeast for her lifelong contributions to Haida language and literature. Erma dedicated her life to gathering, recording, documenting and teaching the Haida language, and was the author of numerous books, including *The Gospel According to John in Haida* (Kasaan dialect), a lifelong project she was pleased to have published in 2009.

Erma was known for her beautiful singing voice, and enjoyed translating gospel songs into Haida. In honor of her tremendous talents and immense contributions we have included a list of Kasaan Haida names she compiled, and also her handwritten Haida language version of the well-known and beloved Kasaan song, "A Wolf Sings to the Raven." Please join us in singing this song in her memory at our annual fundraising dinner Saturday, November 5 at the Cape Fox Lodge in Ketchikan.

Ha'waa Áljuhl for your kind spirited and loving contributions. May we honor your memory by emulating you in all our actions and words.

Kasaan Haida Heritage Foundation History

In Honor & Memory of Willard Lear Jones (Nástao) 1930-2007

Inspired by shareholders suggestions for Kasilco to address our cultural needs, John Campbell brought the idea of a heritage foundation, and in 1999, the Kasilco Board of Directors formed the Kasaan Haida Heritage Foundation (KHHF) a 501(c)(3) tax exempt organization to create a vehicle to support worthy Kasaan Haida history, cultural, and language documentation projects. Because Kasilco is a registered investment company, it is legally obligated to generate profits for shareholders and cannot use its financial assets for cultural heritage activities. Yet Kasilco recognized the importance of documenting Kasaan's unique history and culture, and so created KHHF, a separate organization dedicated to collecting and sharing information about Kasaan. KHHF relies solely on volunteers and donated funds.

KHHF founding officers were Kenneth Gordon, President; John Campbell Vice President, and Jeane Breinig, Secretary/Treasurer. Laird Jones is the current president. KHHF recently added an Advisory Committee including Della Coburn, Juanita Smith Fisher, Eleanor Hadden, Mike Jones, Frederick Olsen, Jr., Richard Peterson, and Jonathan Wunrow.

Gá sa áan Xaadas Guu suu: Kasaan Haida Elders Speak & Surviving Sounds of Haida

Because of concern for elders, one of the first projects KHHF pursued was an Oral History Interview Project which resulted in a video project entitled *Gá sa áan Xaadas Guu suu: Kasaan Haida Elders Speak* (2002) available for purchase on the KHHF website <http://kasilco.com/aboutkhhf.html>.

This project was based on cultural revitalization activities spearheaded by Willard Jones (Nástao 1930-2007) a former Kasilco Board member who dedicated much time, energy, and personal resources to gathering and sharing information about Kasaan. The 2002 Kasaan Haida Elders Speak project was modeled on an earlier project Willard Jones initiated in 1997. He invited Kasaan elders Erma Lawrence, Norman Charles, David Peele, Harriet McAllister, Julie Coburn, and Catherine Kerstetter to a special lunch held at the Ketchikan Indian Center where they shared stories and memories about their life experiences in Kasaan. Frederick Olsen, Jr. was invited to videotape the event, and this project inspired many to do more towards documenting Kasaan Haida elders' perspectives.

On behalf of KHHF, Jeane Breinig wrote a successfully funded proposal to the Alaska Humanities Forum (AHF). \$11,554 was awarded to fund *Gá sa áan Xaadas Guu suu: Kasaan Haida Elders Speak*, which Kasaan people enthusiastically supported. Generous cash donations from Chris and Jeane Breinig, Hank Brouillette, Jr., John Campbell, Della Coburn, Julie and Perry Coburn, Audrey Escoffon, Dorothy Evener, Kenneth Gordon, Eleanor and Ronald Hadden, Caroline Hendrixson, Louis and Lathalia Jones, Catherine Kerstetter, Erma Lawrence, Alton McAllister, Organized Village of Kasaan, Elaine Privett, Sealaska Heritage Institute, Shelly Smith, Minnie Stevens, and Linda White contributed matching funds to financially support the project.

Willard Jones, Project Director and Executive Producer, provided overall direction and cultural guidance. He was responsible for developing the "seaweed gathering" documentation portion of the film and donated the use of his boat. Willard also donated his cash honorarium to KHHF. Others provided housing/interview space to elders and project participants. Willard and Mary Jones, Frederick Olsen, Sr., Inga Olsen, and Sharon Brooks provided housing to project participants, during the Ketchikan interviews. Julie, Perry, Della Coburn, Juanita Smith Fisher, and Marjorie Zeman provided Kasaan housing. Louis Thompson identified the houses in Kasaan during its peak population.

Sealaska Discovers an Ancient Haida Canoe Near Kasaan



A surveyor working for Sealaska Corporation stumbled across a surprise last winter while checking land the corporation owns near the community of Kasaan on Prince of Wales Island. He found an ancient partially-carved Haida canoe, almost 34-feet long, buried under a thick layer of moss.

After the spring snowmelt cleared way for easier access to the site, tribal members from Kasaan joined leaders from Sealaska to visit the canoe—the group discovered at least five cedar trees at the site had been hand-crafted with traditional, non-commercial tools.

“Other abandoned canoes have been found in Southeast Alaska, but it is rare to find canoes crafted with traditional tools,” said Rosita Worl, president of Sealaska Heritage Institute (SHI). “We believe sites like this one will be better protected and preserved under Alaska Native ownership. The canoe symbolically unites past, present and future.”

Discovery of the canoe coincides with Sealaska’s decision to include historic and sacred sites as part of its land legislation (H.R. 1408 and S.730) that has been presented to Congress by Senators Mark Begich and Lisa Murkowski.

“With 40 years of hindsight, we can see that a number of restrictions placed on Sealaska’s ability to select lands both increase the likelihood of community conflict and restrict their ability to engage in more sustainable economic development for the region,” Begich said on October 8, 2010, during his testimony introducing the bill. “[S.730] is an attempt by the Sealaska Corporation to achieve a balance in their remaining land selections.”

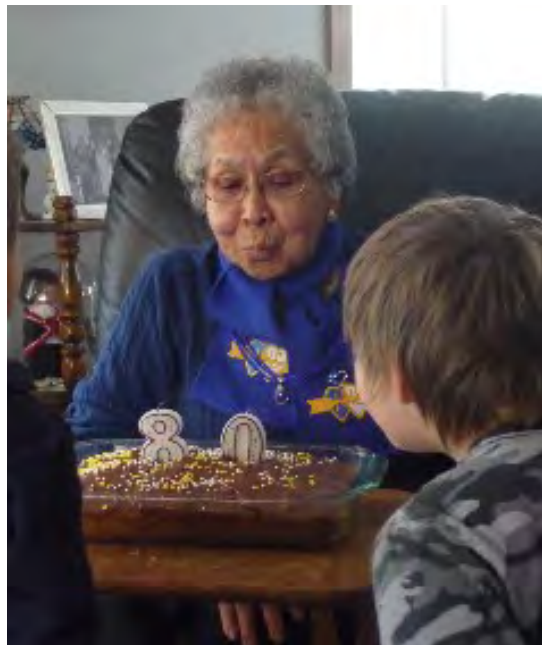


Mary Jones Birthday Celebrations

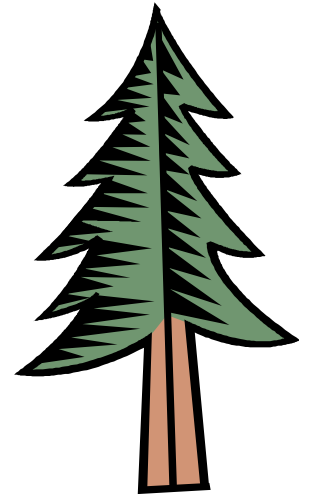

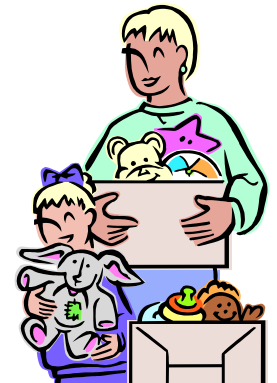

In 1996, Kavilco Incorporated started the process to establish the Kasaan Haida Heritage Foundation (KHHF) as a non-profit corporation in the State of Alaska. In 1999, KHHF became incorporated, with three members of Kavilco's Board of Directors serving as officers — Kenneth Gordon, President; John Campbell, Vice President; and Jeane Breinig, Secretary/Treasurer.

The concern was clear that an effort should be made to document and preserve our culture. The projects important to the cultural heritage of the Kasaan Haida people include clan house and totem pole restorations, Haida language perpetuation, repatriation of Kasaan artifacts, videotaping and interviewing our elders, and cleaning up the creeks near Kasaan for the return of salmon runs.

Our mission is to honor the vision and unselfish actions of our Kasaan Haida ancestors and elders. Kasaan Haida Heritage Foundation aims to document, preserve and promote those things that make the Kasaan Haidas unique.

continued from page 3... Eleanor Hadden, with her Anthropology education and oral history training, was the project's "lead" interviewer. She developed interview questions and invited community input before finalizing them. She also transcribed the audio tapes which are now stored at the Elmer Rasmuson Oral History Depository in Fairbanks. Jeane Breinig assisted with interviews, and in collaboration with Charisse Dwyer, former Kavilco Corporate Secretary, handled administrative functions including ensuring compliance with AHF grant requirements. Frederick Olsen Jr., the project's "Media Specialist," filmed, edited, and created the final video.

The project ended with \$1500 remaining funds. AHF allowed the funds to be used towards a second video, "Surviving Sounds of Haida" (2007) based on portions of the first project and new footage. This film received a "Best in Documentary" award in 2008 from the 2nd Annual Indie Short Film Competition.

Elders interviews included in the films were Pauline Blackstad, Julie Coburn, Willard Jones, Erma Lawrence, Mae Leask, and Harriet McAllister. Portions of Willard's interview, quoted on page 3 of this article, highlight the community effort needed to successfully complete KHHF projects. Many, many people donated food, transportation, and contributed in numerous small and large ways to the two films' success. We honor Willard's memory and all the other dearly beloved elders no longer with us by working together with respect and gratitude for each person's unique contributions.

In addition to these projects and films, KHHF has worked with Kavilco's current Corporate Secretary, Deanna Kaulay, to develop the linked KHHF website which includes a large Kasaan Haida photo collection. As well, Louis Thompson's Kasaan historical documents have been scanned and stored.

Looking Forward: Naay 'Iwaans/Whale House

KHHF's current priority is the restoration of Naay 'Iwaans/Whale House. In 2008, through the efforts of Louis Thompson, Deanna Kaulay, MRV Architects, KHHF and OVK, the Foundation was awarded a \$36,124 National Park Service grant to be used in the planning phase of Naay 'Iwaans/Whale House restoration. Several fundraising dinners have garnered approximately \$26,000 in donated funds which will be used towards matching grant funds we hope to secure. In 2009, Kavilco and KHHF partnered with OVK by signing a Memorandum of Understanding establishing the roles and responsibilities towards the restoration and upkeep of Naay 'Iwaans/Whale House.
